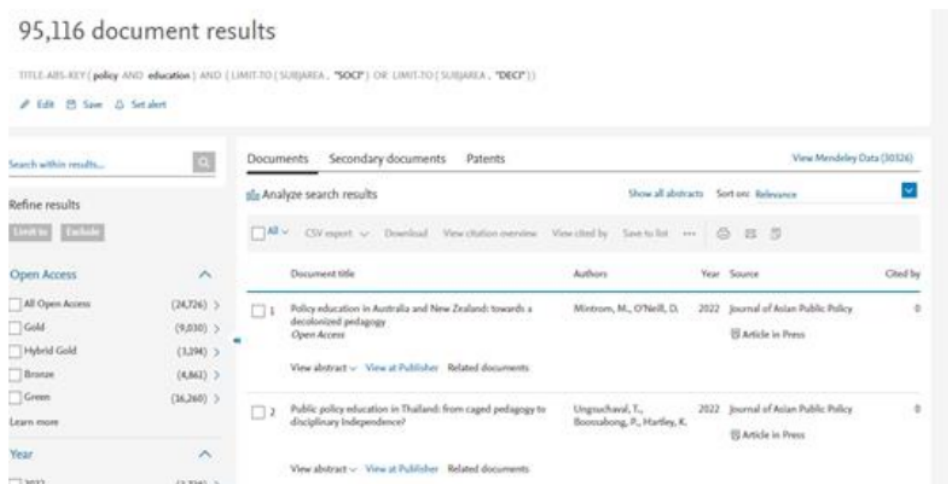

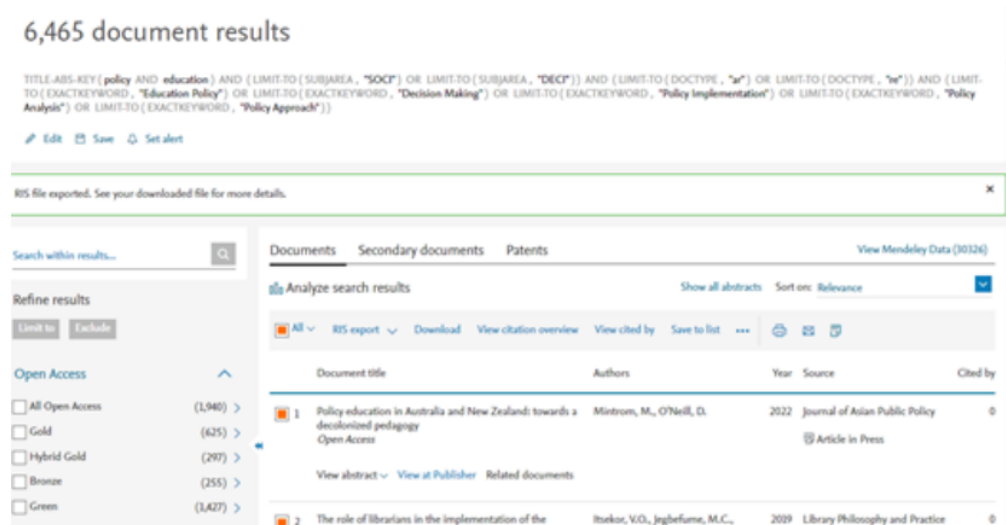
Figure I. number of first searches of public policy and education documents on scopus.

Gambar I. NETWORK VISUALIZATION

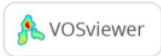
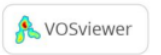
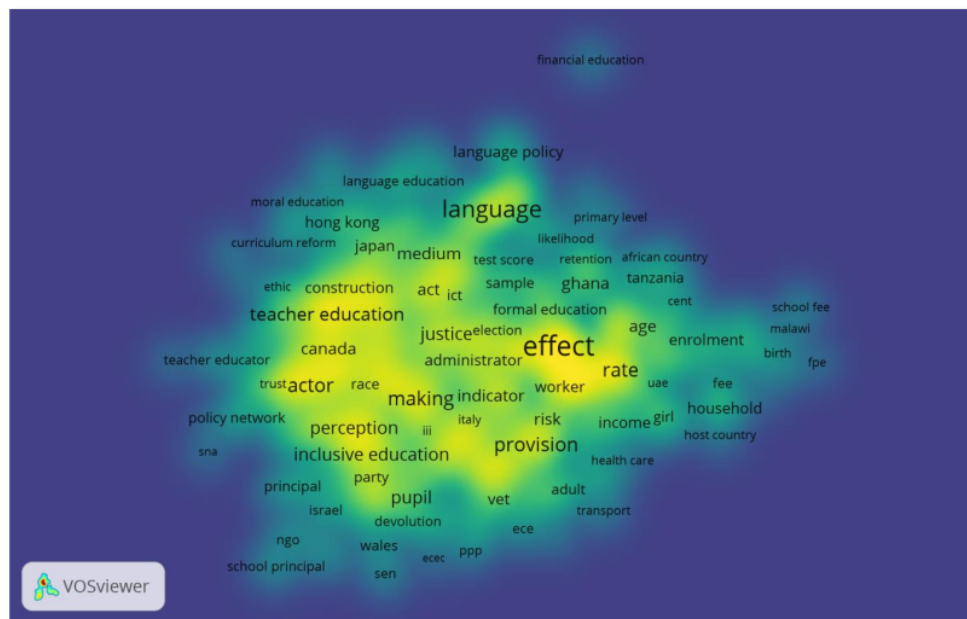


Figure III. NETWORK VISUALIZATION
