CHAPTER I

INTRODUCTION

1.1 Background of the research

In comunication, the relation between language and society cannot be separated. The study about language and society is called sociolinguistics. According to Wardhaugh (2002) sociolinguistics is concerned with investigating the relationship between language and society with the goal being a better understanding of the structure of the language and of how languages function in communication.

Nowdays, many people can speak another language than their native language. They can speak until two and more languages to communicate. Because , in the world there are many countries. then, Indonesia is on of the developing contries that have many cultures in which it has many tribes such as Bataknese, Sundanese, Javanese, Malaynese, etc. Every tribes has role to manage the community inside it. Automatically this influences all aspects in Indonesia, one of which is Language.

To communicte with people among their regions, people use the national language. They need to master more than one language to communicate an to interact with other among their regions. They will use two or more than two languages are called multilingualism.

Therefore, in multilingual community, speaker tends to mix one code to other code, which called code mixing. According to Trudgill (2008:15) "code mixing as the process where by speakers indulge in code switching between language of such rapidity and

density, even within sentences and phrases that are not possible to say at any given time which language they are speaking". Nababan (2008) code mixing happens when people mix two language (or more) language in such speech act or discourse without any force to do mixing codes. Code mixing can be seen in spoken and written language. Code mixing in the study is in spoken language such as in reality show.

The description above happen in english department of UIR pekanbaru, where the student and lecturer will mix their language in communication or in the teaching and learning process. Especially, based on the explaination above as stated before, also happens at Al Amin boarding school located in Afd II Rawang Kao, Lubuk Dalam subdistric, Siak. which the inhabitants are from malay, javanese, bataknese. Where the student (santri) will mix their language to interact each other. Related to the language usage at the boarding school, the boarding school student should speak Arabic and English language in daily life. But in communication, sometimes they take a part of arabic into English or English into Indonesia and sometimes they will take a part english-arabic-Indonesia. So, to avoid from the punishments students will mix their language for two code English-Arabic or Arabic-English. The students will get the punishment when the student do not used both of language, means they use an Indonesian language (bahasa) and another language such national language or their own language.

In Al amin boarding school makes languages as the crown. Arabic is an main language of them. In other definition, language is our crown atau al-lughatu taaju-lma'hadi. The possessions in language is more than any attribute, distinguishes human from other animals. So, bilingualism and multilingualism is one of the cause of code-mixing, which most striking phenomena in a bilingual's and multilingual's linguistic perfomance is the occurence of the seemingly of two languages. Both within and between utterances, during a conversational exchange. The ability in mastering some languages also can be the main factor of code mixing . code mixing is when the people use more than ne language at the same time in a conversation.

The research is studying the process of mixing the code of English into Arabic and Indonesia used by the boarding school students. So base on the explaination before, The writter is interested in carrying out a research entitle "**An Analysis of Code Mixing in Daily Conversation at Al Amin Boarding School**".

1.2 Identification of the Research

Code mixing is the application of a language or more in which put th elements of language as the word to the other language consistenly. Code mixing could appear in every context of communication, like in students of Al Amin Boarding School.

Based on the background above, the researcher found that some of the student at al amin boarding school still speak Arabic and English is difficult. The student faced some problems as follows :

- 1. The student do not confidence in English, Some of them feel ashamed and afraid for making mistake in pronouncing word (speaking).
- 2. Some the student seldom speak English fully and use code mixing in their conversation
- 3. The student are still lack of vocabulary and not mastering the grammar yet.

- **1.7.4 Boarding school** is a school which some or all of the pupils live in during the school term. It means boarding school as islamic education, where the students study and live inside. most of them have an english speaking system, in particular arabic language.
